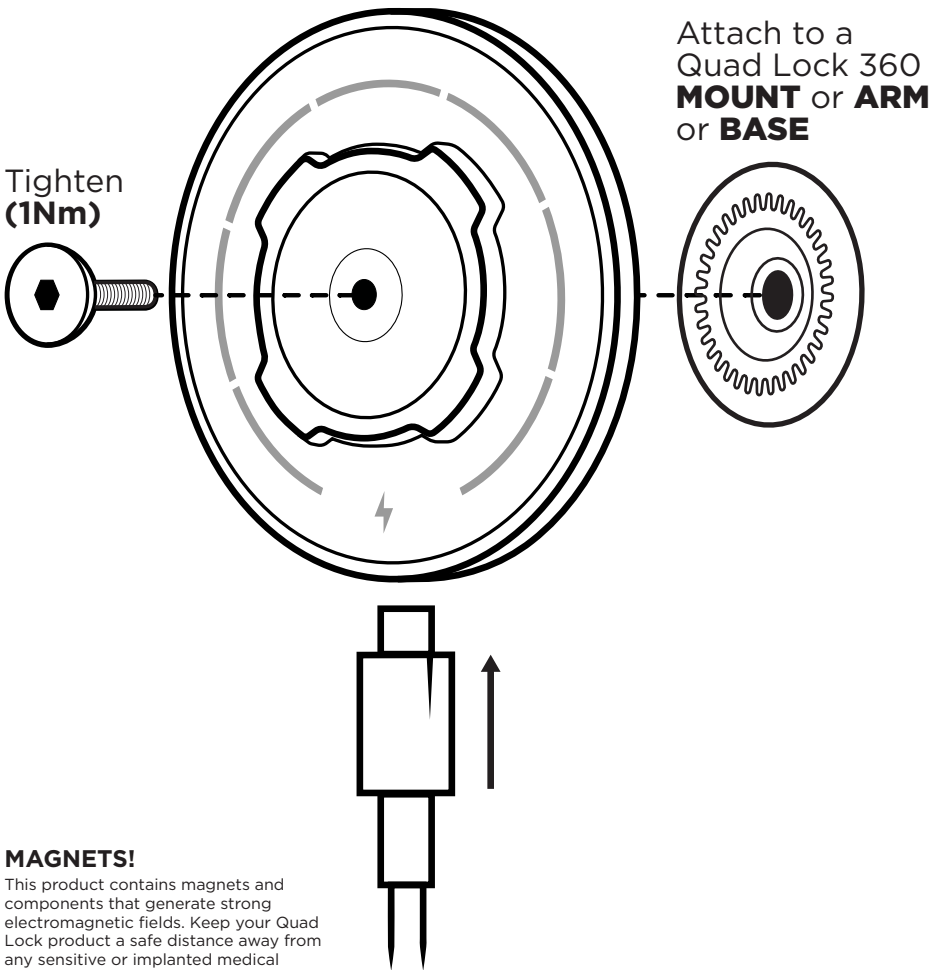

MAGNETS!

NOTE: The "MAG Wireless Charger Head" has been tested and found to comply with the limits for a Class B device, pursuant to Part 15 of the FCC Rules and has been assigned FCC ID: 2AQU9-QLH2. These limits are designed to provide reasonable protection against harmful interference. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications.
